Introduction

In January 2019 the Department for Education (DfE) published the Early Career Framework (ECF) and in November 2019 DfE published the initial teacher training (ITT) Core Content Framework (CCF).

The CCF defines in detail the minimum entitlement of all trainee teachers. Drawing on the best available evidence, it sets out the content that ITT providers and their partnerships must draw upon when designing and delivering their ITT programmes. More information about the CCF is available here:

The ECF sets out what early career teachers are entitled to learn about and learn how to do when they start their careers. It underpins the entitlement of early career teachers to receive two years of professional development designed to help them develop their practice, knowledge and working habits. Both the CCF and ECF were based on the most up-to-date research into excellent teaching practice. The Education Endowment Foundation (EEF) independently reviewed the frameworks to ensure they draw on the best available evidence and that this evidence has been interpreted with fidelity.

However, evidence does not stand still, and when launching the CCF and ECF DfE committed to updating the frameworks as research progresses. Building on what we have learned from the first few years of CCF implementation and ECF delivery, we plan to review and revise the ITT CCF and ECF into more closely combined frameworks which cover the first three years or more at the start of a teacher's career and articulate what trainee and new teachers need to know and need to know how to do.

We are therefore seeking recent, relevant and high-quality research that may inform amendments to the existing frameworks. It is not anticipated that this will involve a fundamental rewrite of the frameworks. The aim is to build on what is there to ensure the frameworks are up to date and fit for purpose. Any new evidence submitted will be considered by DfE and appraised by the EEF on the basis of whether it is robust, relevant and helpfully supplements the existing evidence cited in the framework.

Who this is for

We are interested in collecting evidence from individuals or organisations with specialist expertise in education and pedagogy with knowledge of research that will inform our work on the frameworks, including:

Academic researchers

- Pedagogy and education experts
- Research organisations such as universities
- Education charities, private organisations, and public bodies that commission and/or review education research
- SEND charities, private organisations, and public bodies that commission and/or review education research

How responses to the call for evidence will be used

Any new evidence submitted will be considered by DfE and EEF on the basis of whether it is robust, relevant and helpfully supplements the existing evidence cited in the framework. Decisions about amendments to the frameworks will be taken by the DfE, working with panels of experts. The final frameworks will be independently reviewed and quality assured by the EEF to ensure they draw on the best available evidence and that this evidence has been interpreted with fidelity. It is not anticipated that this will involve a fundamental rewrite of the frameworks. The aim is to build on what is there to ensure the frameworks are up to date and fit for purpose.
